Interest Compounding and Crediting Frequency	 Interest will be compounded and calculated daily. Accrued interest will be credited to your account monthly. We will use an interest accrual basis of 365 (or 366 in a leap year) for each day in the year. Accrual of interest begins on the business day you deposit noncash items (for example, checks). Accrued interest is forfeited if the account is closed before the interest is credited to the account.
